## Field Rates and Policies

### RENTAL RATES:

1. \$25 processing fee for all applicants.
2. \$35.00 per hour under 4 hours.\* More than 4 hours constitutes "all day use." No half-hour field use charges; all rounded up to next full hour.
3. Entire complex: \$280.00 per day (Strong's field); \$280.00 per day, plus \$50.00 per additional field (Church & Belmont St. fields)
4. East Bridgewater-based organizations pay only \$25 processing fee.

### RAINOUT AND CANCELLATION POLICIES:

1. Commission will make every effort to reschedule alternate dates for rainouts or other postponements during the season, whenever possible.
2. Sorry, **NO** next-season credits or refunds for rainouts or other cancellations over which the Town of East Bridgewater has no control.

\*all day rentals may run from 7:00 a.m. until ½ hour prior to dusk.
